INTRODUCTION:

The National Poverty Graduation Programme (NPGP) is an International Fund for Agricultural Development (IFAD) and the Government of Pakistan (GOP) funded, US\$ 132.59 million in programs to be implemented over a period of 6 years. The programme aims to assist the ultra-poor and very poor in graduating out of poverty on a sustainable basis while simultaneously improving their overall food security, nutritional status, and resilience to climate change. The development objective of the project is to enable the rural poor and especially women and youth to realize their development potential and attain a higher level of social and economic wellbeing through a proven, flexible, and responsive menu of assistance. The poverty graduation approach in the NPGP combines elements of three distinct approaches of social mobilization, livelihoods development, and financial inclusion. In this process, the capacity-building of community organizations through strong social mobilization support is key to support individual households to access multiple opportunities.

LASOONA-Relief and Development Organization is a national, multi-disciplinary, development focused, nonprofit organization. It was established in 1997 by a dedicated and visionary group of motivated and civicminded people with a passion to support human and natural resource development in vulnerable and impoverished areas of Pakistan. In 1998, it was registered as an NGO under Societies Registration Act, 1860. In 2023, the organization was incorporated as a not-for-profit Company and registered under section 42 of the Companies Act 2017 with Securities and Exchange Commission of Pakistan (SECP). LASOONA is also certified/accredited by Pakistan Centre for Philanthropy (PCP), and has a tax exemption status from Federal Board of Revenue, Government of Pakistan under Section 2(36) of Income Tax Ordinance.

LASOONA-Relief and Development Organization is partner organization of NPGP and is carrying out activities in six districts including Shangla, Torghar, Battagram, Lower Kohistan, Upper Kohistan and Kolai Palas Kohistan of Khyber Pakhtunkhwa. The Programme is designed to graduate household out of poverty building largely (but not exclusively) upon BISP beneficiaries and leveraging the Prime Minister Interest Free Loan (IFL) Scheme to build a smooth 'seamless service' where the poorest can move out of poverty through a blended programme extended from consumption support to asset transfer to Interest Free loans to microcredit.

Under Poverty Graduation component of the project, marketable Skills and Vocational Trainings are planned for youth (women and men) in the above-mentioned districts. The objective of these training is to equip the

youth with skills required in local, national and international market in order to enhance the employability and earning capacity of youth. These youth will be given a comprehensive tool kit after completion of training.

The Government of Pakistan has received financing from the International Fund for Agricultural Development ("the Fund" or "IFAD") towards the cost of National Poverty Graduation Programme (NPGP) ("the client" or "procuring entity"), and intends to apply part of this financing to the purchase for which this request for quotations (RFQ) is issued.

The use of any IFAD financing shall be subject to IFAD's approval, pursuant to the terms and conditions of the financing agreement, as well as IFAD's rules, policies and procedures. IFAD and its officials, agents and employees shall be held harmless from and against all suits, proceedings, claims, demands, losses and liability of any kind or nature brought by any party in connection with National Poverty Graduation Programme (NPGP).

LASOONA is invites sealed quotations on single stage one envelope procedure from suppliers /company/Firm/Dealer involved in the business of tool kits related to Motor Cycle Repairing tools, Basic Electrician tools, Mobile Repairing tools, and plumbing tools kits on single stage one envelops procedures.

Note: This document is not a contract or an offer of contract, but is a formal request for quotation of required services. Bidders must read, sign/stamp each page of this document for compliance with the terms and conditions given below.

1. Delivery Duty Paid (DDP)

"Delivery Duty Paid" means that the seller delivers the goods to the buyer, cleared them for import, and is not unloaded from any arriving means of transport at the named place of destination. The seller has to bear all the costs and risks involved in bringing the goods there including any "duty" (Which term includes the responsibility for and the risks of the carrying out of customs formalities and the payment of formalities, customs duties, taxes, and other charges).

2. Scope of works:

Detail specification have been given in the quotation form attached herewith. Quantities can be increased/decreased subject to availability of budget and need of the organization.

For more detail and items specification please refer to the Quotation form attached at the end of the document.

3. Documents Required

Bidders must attach the following documents with their bids. Bids can be rejected based on deficiencies in the documents.

- a. A valid copy of Registration/License from the Chamber of commerce
- b. Call Deposit 5% of the quoted amount from the business account only
- c. Fresh bank Statement in the name of the firm covering the last 06 months period
- d. Ownership proof or Power of attorney for the person other than the real owner of the company
- e. Proof of Similar services in the past (LASOONA has the right to cross-check the previous supplier's contacts or purchase orders)

- f. Active and Valid Taxpayer, NTN number, and/or Valid Tax Exemption Certificate
- g. Quotation on prescribed format including all applicable taxes in PKR.
- h. Affidavit on the stamp paper (Original copy attested by a notary public) that company/firm has not been blacklisted by any Government or semi-Government departments or NGO/INGO.
- i. The supplier will sign and submit all the attached annexures.

4. Selection Criteria

Bidder's documents shall be evaluated based on the following criteria:

- a. Registered Relevant business
- b. Relevant Experience with supplies
- c. Agree with all terms and conditions of the Organization
- d. Reasonable quoted rates within the approved budget
- e. Quality of sample/satisfactory presentation

5. Bids Evaluation

Bids will be evaluated based on the technical and financial proposal with assigned percentages to each component as follows:

Technical Component	=	40Marks (40% weightage)
Financial Component	=	60Marks (60% weightage)

Technical Component:

Similar services in the past 20Marks (Detail Profile, having contracts/supply orders and completion certificate, etc.) Quality (Sample) = 20 Marks

Financial Component:

The maximum number of points will be allotted to the lowest rate offered by the bidder. All other price proposals will receive points in inverse proportion to the lowest price; e.g., Lowest quoted price/Quoted price x 100= total marks obtained 60% of weightage.

Please note, the lowest quotation is not the sole criterion for the selection of bid, LASOONA will thoroughly check the organization's strength, quality of the sample, agreement with organizational policies and procedures, and terms and conditions of the tender.

6. Sample Presentation

The shortlisted supplier or suppliers will be asked to dispatch/submit samples for the selected lot(s) items mentioned in the quotation form. Those who could not present their samples for whatever reasons on the preannounced date shall be excluded from the further process. The final selection will be done on the quality of the sample specified in the tender documents.

7. Validity of the offer:

Quotations must be valid for at least three months period. The validity period can be extended on the mutual consent of both parties.

8. Security Deposit:

All interested suppliers will have to submit a call deposit @5percent of the total quoted rate of the respective lot/lots in the name of LASOONA. Call deposits must be made/withdrawn against the supplier business account only. Quotation submitted without call deposit will not be processed/ considered for further process while Cash/cheque or Bank draft is not acceptable. Call deposits of those who could not be shortlisted for whatever reasons shall be released within two weeks from the date of bid opening. Call deposits of selected suppliers will be released upon request from the contractor and approved by competent authorities on the expiry of the contract and/or successful completion of services.

9. Taxes:

Quotations must be inclusive of all applicable taxes present and imposed during the contract implementation. The firm claims to be tax exempt must provide a n authentic tax exemption

certificate from FBR. Taxes should be included in quoted prices and need not mention separately. Quotations mentioning taxes separately will not be considered.

10. Payment modalities

Payment will be made in one installment upon completion of 100% supply of each lot. All applicable taxes will be deducted at the time of payment. Payment will be made through a cross cheque in the name of the selected firm. The supplier must have to submit the following documents for payment processing. After the Successful delivery of all kits, payment will be processed within 10 working days after the submission of all documents.

- Detail Invoice (Signed & Stamped)
- The way Bill/GRN

11. Penalties

- 1. If, in any case, the selected bidder is not willing to sign the contract for whatever reasons, the company will be penalized by forfeiting the 50% amount of the call deposit money.
- 2. In case after signing the contract, the supplier is not willing to start supplying on the quoted prices and all terms and conditions of tender documents, the supplier contract will be terminated and 100% of the call deposit will be forfeited.
- 3. If the Supplier provided low-quality items/goods, the supplier will be bound to replace the items at his own cost within a week otherwise his contract will be canceled, and 100% of the call deposit will be forfeited.
- 4. In the event of delay in the completion of work caused other than by force majeure, the client (LASOONA) is entitled to make use of a penalty of 5/1000 (Five per thousand) per day of the total value of the agreed amount based on a work order issued from the office of the competent authority. The penalty will be deducted from either the call deposit or invoice.

12. Packing/packaging and printing:

Each Kit must be properly packed in an appropriate packing carton, toolbox, bag, or any other environmentfriendly material. Quoted prices must be inclusive of delivery charges to respective locations. Organizational logos, project name with description, and Safety instructions may be displayed/printed in multi colors on each pack/kit.

13. Delivery timeframe and Place of delivery

The Supplier must provide the ordered tool Kits within 15 working days after signing an agreement and or as per the signed purchase order. All Goods/items will be supplied to LASOONA warehouse at Besham, District Shangla.

14. Submission of Offer

- 4. Quantities are subject to alteration. LASOONA reserves the right to award the contract of all lots to one bidder or divide them among different bidders.
- 5. Part of the tender or tender as a whole can be canceled without assigning any reasons.
- 6. LASOONA reserves the right to regret/reject any offer without transmitting any reason.

- 8. Only short-listed bidders will be contacted for the final interview meeting
